Residence Hall Agreement

I. INTRODUCTION

Armstrong Atlantic State University (hereinafter “the University” or “AASU”) and the undersigned resident student (hereinafter “the resident” or “student”) hereby agree to the following terms and conditions.

This Residence Hall Agreement (hereinafter “the Agreement”) is not a lease but a license to use the facilities and is binding for the entire academic year. The University shall provide the resident with an assigned space in a residence hall (hereinafter “the premises”) if space is available. The assignment shall commence and terminate as indicated in Section III below.

Execution of this agreement does not guarantee that space will be available in University Housing. Students for whom space is not available will be assigned to a waiting list and will be notified if space becomes available.

All materials contained herein are an integral and binding part of this agreement. Residence hall policies and regulations in the AASU Student Handbook and the University Housing & Residence Life Rules and Regulations, the Housing & Residence Life website (<http://www.housing.armstrong.edu>), and AASU Undergraduate and Graduate Catalog are hereby incorporated by reference into this agreement and are binding on all parties to this agreement. It is the resident’s responsibility to become familiar with all provisions of this agreement and the incorporated documents.

No oral statement made by any employee or agent of the University shall be considered a waiver or modification of any term or condition set forth in this agreement.

II. DINING SERVICE REQUIREMENT¹

All students residing in University Housing are required to participate in one of the University’s dining plan options.

III. DATES OF OCCUPANCY²

The University offers two different housing agreements: a three semester agreement (fall spring, and summer terms) and a two semester agreement (fall and spring terms). The three semester agreement commences on August 14, 2010 at 9:00 a.m. and terminates on July 08, 2011 at 10:00 a.m. The two semester agreement commences on August 14, 2010 at 9:00 a.m. and terminates on May11, 2011 at 10:00 a.m.

Note: A limited number of two semester agreements are available for apartments. All students living in Windward Commons will have a two semester agreement. Students who do not want housing during the summer term should request a two semester agreement.

Note: A new Residence Hall and Dining Service Agreement must be submitted each Spring by the designated deadline if the Student desires to stay in University Housing during the next academic year.

IV.GENERAL TERMS AND CONDITIONS

A. Purpose

The student will use the premises for residential and educational purposes in accordance with this agreement. The premises shall not be used for commercial purposes. Door to door solicitation, distribution, and advertising for commercial or religious purposes is strictly forbidden.

B. Enrollment Requirement

Undergraduate students must be enrolled in a minimum of 9 credit hours during the fall and spring semesters to be eligible to live in University Housing. Graduate students must be enrolled in at least 3 credit hours during the fall and spring semesters to live in University Housing. *Please refer to the University Housing and Residence Life Rules and Regulations, Section II for summer enrollment requirements.*

C. Assignments

Roommate assignments are made without regard to race, color, religion, national origin, age, personal appearance, family, political affiliation, actual or perceived physical or mental disability, or status.

The University will assign a room based on available housing space after the student – and where appropriate, his or her guardian – has signed this Agreement and paid the required \$250 application fee. *Please refer to the University Housing and Residence Life Rules and Regulations, Section III for additional information concerning assignments and privacy.*

Special needs. Students with special needs including those who need housing accommodations must self identify and must also complete and file a request for housing accommodation with Disability Services at least 60 days prior to the student's anticipated move in date otherwise a room may not be available. See Section VII below.

D. Check-In Check-Out Requirement

All residents must complete the check-in or check-out process when moving into or out of a room in University Housing. This process includes an appointment with a Residence Hall staff member, assessment of room condition/damages, issuing or returning keys, and signing the check-in or check-out form, as appropriate. *Please refer to the University Housing and Residence Life Rules and Regulations, Section V for additional information.*

E. Fire Sprinklers and Alarms

Residents who tamper with a fire sprinkler system and cause a sprinkler head to activate will be responsible for all water damage caused by the sprinkler to the room and other surrounding rooms as well as any damage caused to personal property belonging to another student. Residents who cause damage to a fire sprinkler system will be responsible for all costs incurred to repair the system. Determination of the amount of loss or damage shall be made by the University at its sole discretion. Failure to pay the assessment will result in a hold of the student's registration, graduation, or issuance of transcripts and may result in termination of the student's housing agreement.

F. Room Entry

The University may enter student rooms without notice if it has reason to believe a health or safety emergency exists. However, entry into rooms for routine maintenance will be made only after notice of the inspection and entry is provided at least 24 hours in advance. The University is guided by the "Plain View Doctrine" and may report evidence of unlawful

acts in "Plain View". *Please refer to the University Housing and Residence Life Rules and Regulations, Section VIII for additional information.*

G. Alcohol and Illegal Drugs Prohibited

Alcoholic beverages, illegal drugs, and drug paraphernalia are prohibited on the University campus and in University Residence Halls. *Please refer to the University Housing and Residence Life Rules and Regulations, Section XIII and XV for additional information.*

H. Hazardous Materials and Prohibited Items

Students may NOT possess explosives, firearms, chemicals, open flame burning items, bows or weapons or any other materials or items that may be considered hazardous to the health and/or safety of student and/or others. *Please refer to the University Housing and Residence Life Rules and Regulations, Section IX for additional information.*

I. Smoke Free

University Residence Halls are smoke free. All common area spaces in a residence hall including hallways, lounges, lobbies, and stairwells are smoke-free environments. *Please refer to the University Housing and Residence Life Rules and Regulations, Section XIV for additional information.*

V. RATES AND PAYMENT³

A. Residence hall room rates are outlined in the "Community Selection" section of the attached Application. Room rates may be changed after 30 days notice in the event of unanticipated circumstances beyond the control of the University, including but not limited to increased utility rates. Each student resident is also required to select a meal plan. See Section II above.

B. The undersigned student agrees to make housing payments to the University for the full duration of the Housing Contract. Payment for each semester must be made in full prior to the beginning of the semester. The University has instituted the following payment schedule for the 2010-2011 academic year:

Student housing payments must be received in full on or before the due dates. Housing Fees are due to

the Bursar's Office no later than 4:00 PM on the due dates listed above. A student who moves in after the first day of classes of a given semester must pay housing fees upon move-in. If the amounts due for student housing are not received in the Bursar's Office by the payment deadline, the University reserves the right to reassign the space to another student.

The undersigned student understands that failure to satisfy his/her financial obligations may result in penalties, including, but not limited to, removal from University housing, suspension, blocking or canceling of class registration, and/or the refusal to issue transcripts or diplomas.

C. This agreement is enforceable for the specified term regardless of whether the student transfers, withdraws, is suspended from AASU, chooses to live off-campus, or if the student's physical, mental, emotional condition or parental or marital status changes or the student encounters family or financial hardship or the student is administratively removed from University Housing or for any other reason is unable to continue occupying the assigned space. **The Student's obligation to pay housing expenses hereunder shall continue for the entire term of this Agreement.** See Section VI below.

D. Failure to provide electricity, hot and cold water, heat and/or air conditioning, cable service, and / or internet service shall not be a reason for reduction, abatement, or withholding of housing payments or other payments due. No housing fee adjustment or other compensation shall be claimed by the Student for inconvenience or discomfort from repairs or improvements to facilities or temporary service outages, provided such occurrences are resolved.

E. Student understands and agrees that he/she shall reimburse University for any and all costs incurred by the University (or any entity acting on University's behalf) in any action for collection of sums due hereunder, including, but not limited to, court costs, collection agency fees, attorney's fees, interest fees and any other related fees. Failure of the University to enforce or pursue any of its rights hereunder shall not act as a waiver of that right or any other right to later exercise any right or enforce any remedy which it may have at law and/or equity.

F. The student understands and agrees that the agreement is for space in the residence halls and not for a specific room or building. In consideration of the assignment of the room, the student agrees to pay the University the appropriate charge for that type of room.

G. Failure by the student to pay for all charges does not constitute the cancellation of this agreement by the student.

VI. CANCELLATIONS

Any student wishing to request cancellation of their agreement must submit a Residence Hall Agreement Cancellation Request Form (available online or in Housing & Residence Life) to Housing & Residence Life. Cancellations will not be deemed terminated until officially approved. *Please refer to the University Housing and Residence Life Rules and Regulations, Section IV for additional information.*

VII. HOUSING ACCOMMODATIONS DUE TO DISABILITY

If housing accommodations are needed under the American with Disabilities Act, **a completed Housing Accommodation Request Form must be submitted to the Office of Disability Services at least 60 days prior to anticipated occupancy.**

The University has a limited number of rooms designed to accommodate wheelchair access. Students who desire or need an ADA compliant room must have a completed Housing Application and a completed Request for Housing Accommodation on file no later than June 15, 2010 for the Fall 2010 semester; November 8, 2010 for the Spring 2011 semester; and April 15, 2011 for the Summer 2011 semester.

The University will release all unassigned ADA compliant rooms for use by other students after June 15, 2010. As such, the University may not be able to accommodate a request for housing accommodations made after June 15, 2010.

The request for housing accommodation must be supported by a diagnosis of disability by a qualified medical provider with appropriate documentation. The Housing Accommodation Request Form can be downloaded from either the Disability Services webpage or from the Housing & Residence Life webpage:

Note: A diagnosis in and of itself does not automatically qualify for a requested accommodation.

VII. UNIVERSITY LIABILITY

Although security precautions are taken, the University does not assume any legal obligation to pay for injury to person (including death) or damage to automobiles or to items of personal property which occurs in University buildings or on University grounds prior to, during, or subsequent to the period of this Agreement. Students or their parents are encouraged to carry appropriate insurance to cover such losses. National Student Services, Inc (<http://nssinc.com>) and CSI Insurance Agency, Inc. (<http://www.collegestudentinsurance.com>) are two carriers that provide personal property coverage. Depending on the policy, personal property coverage would protect such things as laptops, Mp3 players, musical instruments and other property from theft, fire, vandalism etc.

The University requires all students including residents of University Housing, to pay student health fees.

IX. GOVERNING LAW

This Agreement shall be interpreted and construed in accordance with the laws of the State of Georgia. Any dispute over the terms of this agreement shall be brought in Superior Court in Chatham County Georgia. Both parties hereby consent to personal jurisdiction of the Superior Court of Chatham County, Georgia.

X. SIGNATURES

By signing and submitting this Residence Hall Agreement, the student voluntarily agrees to and understands that he/she will be bound by the terms and conditions outlined in this Agreement and in the University Housing and Residence Life Rules and Regulations and other documents that have been incorporated by reference as identified in Section I above. The student certifies that he/she is at least 18 years of age or the student's parent or legal guardian is signing below. A parent or guarantor signature does not give any additional contractual rights or allow a parent or guarantor to receive any information protected by the Family Educational Rights and Privacy Act (FERPA).

Student agrees to provide the information requested on the housing application for the purpose of room and roommate assignments. Specific requests are honored when possible; however they are not guaranteed.

My signature below also authorizes the University to apply my financial aid against any and all charges related to Housing and meal plan fees. All Housing and meal plan fees are due in full on the due dates listed in the Housing Agreement.

My signature below acknowledges that I understand AASU recommends that each resident purchase private personal property insurance. AASU has identified two companies that provide insurance: National Student Services, Inc. (<http://nssinc.com>) or CSI Insurance Agency, Inc. (<http://www.collegestudentinsurance.com>). I acknowledge that it is my decision whether to purchase a personal property insurance plan.

I understand that all residents are billed \$30 per fall and spring semesters for the Residential Life Activity Fee.

Meningococcal Disease Notification

You must read and sign the following in order to receive your housing assignment. If you are under the age of 18, you must have a parental or guardian signature.

As of January 1, 2004, all postsecondary educational institutions in Georgia are required to provide information on meningococcal disease and vaccination to each newly admitted freshman or matriculated Student residing in campus housing (Official Code of Georgia Annotated 31-12-3.2)

1. Meningococcal disease is a serious disease that can lead to death within only a few hours of onset: one in ten cases is fatal and one in seven survivors of the disease is left with a severe disability, such as loss of a limb, mental retardation, paralysis, deafness or seizures.

Meningococcal disease is a bacterial infection caused by *Nisseria meningitides* and occurs when these bacteria, which can live harmlessly in the nose and throat of healthy people, invade the tissues or bloodstream of the body. Meningococemia occurs when *N. meningitides* enters the blood stream; meningitis occurs when the tissue surrounding the brain and spinal cord is invaded; and pneumonia occurs when the bacteria infects the lungs.

2. Meningococcal disease is contagious but a largely preventable infection of the spinal cord fluid and the fluid that surrounds the brain.

Meningococcal bacteria are spread from person to person by direct agreement or intimate exposure with an infected person's oral or nasal secretions, such as saliva or respiratory droplets. Intimate or direct exposure is through kissing, sharing eating utensils or glassware. Fortunately, the bacteria are not as contagious as the common cold and do not spread by being in the same room or breathing the same air as an infected person. The bacteria are not transmitted by routine agreement in classrooms, restaurants, bars and restrooms where an infected person has been.

Approximately 5 to 10% of the general population carries the meningococcal bacteria in the nose and throat in a harmless state. This carrier state may last for days or months and seems to give those individuals who harbor meningococci in their upper respiratory tract some protection from actually developing the disease state.

3. Scientific evidence suggests that college Students living in residence hall facilities are at a moderately increased risk of contracting meningococcal disease.

The incidence of meningococcal meningitis has increased since the early 1990's, including cases at U.S. colleges and universities. Recent data also show Students living in residence halls, particularly first year Students, have an increased risk for the disease.

Data suggests that certain social behaviors, such as exposure to passive and active smoking, bar patronage and excessive alcohol consumption, may increase Students' risk for contracting the disease.

4. Immunization against meningococcal disease will decrease the risk of the disease.

A vaccine is currently available at the Student Health Center, which protects against four of the five serogroups of meningococcal meningitis. It does not protect against serogroup B that accounts for approximately 32% of all cases in the 15-24 year old age group. The vaccine produces protective antibodies in 7-10 days and is effective for three to five years. Adverse reactions are mild and infrequent, and include pain and redness at the site of the injection.

Students should be aware of common symptoms of meningitis including stiff neck, headaches, fever, and sensitivity to light, sleepiness, confusion, and seizures. Meningococcal blood infection causes fever and rash. Anyone exhibiting symptoms should see a health care provider even if they had the vaccine.
