CANCELLATION SCHEDULE**

Academic Year 2017-2018 – Fall Cancellations

- No penalty for contracts cancelled on or before July 1st, 2017
- A \$500 cancellation fee will be assessed to any student who cancels after July 1st, 2017
- Housing/meal plan charges will be fully refunded should a student cancel between July 2nd, 2017 and Fall Move-In. The \$500 Cancellation fee will still be assessed
- Housing/meal plan refunds will be prorated for the number of days a student lives in housing After Fall Move-In through October 1st, 2017. The \$500 cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after October 1st, 2017. The \$500 cancellation fee will still be assessed

Academic Year 2017-2018 – Spring Cancellations

- A \$500 cancellation fee will be assessed to any student who cancels after July 1st, 2017
- Housing/meal plan charges will be fully refunded should a student cancel between Fall Move-Out and Spring Move-In. The \$500 cancellation fee will still be assessed.
- Housing/meal plan refunds will be prorated for the number of days a student lives in housing After Spring Move-In through February 22nd, 2018. The \$500 cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after February 22nd, 2018. The \$500 cancellation fee will still be assessed

Spring 2018 Cancellations – New Residents Only*

- No penalty for contracts cancelled on or before November 1st, 2017
- A \$500 cancellation fee will be assessed to any student who cancels after November 1st, 2017
- Housing/meal plan charges will be fully refunded should a student cancel between November 2nd, 2017 and Spring Move-In. The \$500 cancellation fee will still be assessed.
- Housing/meal plan refunds will be prorated for the number of days a student lives in housing After Spring Move-In through February 22nd, 2018. The \$500 cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after February 22nd, 2018. The \$500 cancellation fee will still be assessed

* This only applies to students who did not have a housing assignment in the fall. This applies to students who have completed the “Spring 2018 Only” application

Fall 2017 Minimester Cancellations

- No penalty for contracts cancelled on or before September 1st, 2017
- A \$500 cancellation fee will be assessed to any student who cancels after September 1st, 2017
- Housing/meal plan charges will be fully refunded should a student cancel between September 2nd, 2017 and Fall Minimester Move-In. The \$500 Cancellation fee will still be assessed
- Housing/meal plan refunds will be prorated for the number of days a student lives in housing After Fall Minimester Move-In through October 5th, 2017. The \$500 cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after October 5th, 2017. The \$500 cancellation fee will still be assessed

Spring 2018 Minimester Cancellations

- A \$500 cancellation fee will be assessed to any student who cancels after February 1st, 2018
- Housing/meal plan charges will be fully refunded should they cancel between February 2nd, 2018 and Spring Minimester Move-In. The \$500 cancellation fee will still be assessed.
- Housing/meal plan refunds will be prorated for the number of days a student lives in housing After Spring Move-In through March 5th, 2018. The \$500 cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after March 5th, 2018. The \$500 cancellation fee will still be assessed

Summer 2017 - Term Sessions 1&2 Cancellations

- No penalty for contracts cancelled on or before May 1st, 2017
- A \$500 cancellation fee will be assessed to any student who cancels after May 1st, 2017
- Housing/meal plan charges will be fully refunded should a student cancel between May 2nd, 2017 and Summer Session Move-In. The \$500 Cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after Summer Session Move-In. The \$500 cancellation fee will still be assessed

Summer 2017 - Term Session 3 and Pirate Passage Cancellations

- No penalty for contracts cancelled on or before June 1st, 2017
- A \$500 cancellation fee will be assessed to any student who cancels after June 1st, 2017
- Housing/meal plan charges will be fully refunded should a student cancel between June 2nd, 2017 and Summer Session Move-In. The \$500 Cancellation fee will still be assessed
- Housing/meal plan charges will NOT be refunded to any student who cancels their housing contract after Summer Session Move-In. The \$500 cancellation fee will still be assessed
